Mancos Valley Chamber of Commerce will fund those projects and programs of our *member organizations* that promote Mancos Valley tourism, encouraging the use of our lodging, shops, restaurants, services and recreational opportunities. To be considered, Grantees must be willing to provide results of their program or project within 30 days of completion. (See results form attached).
